**PAYMENT POLICY:** Upon receipt of this rental agreement the above dates are reserved for you. You may pay with cash (check) or credit card. **Either method of payment must include your credit card information below.** If paying with a credit card there is an additional 5% added to your total. You may split payments in half for a fee of \$20.00. Use the following formula to determine your final cost (Rate per night) x (# of nights) = (\$ \_\_\_\_\_) + (\$100 cleaning) = (\$ \_\_\_\_\_ total) If paying with credit (Total) x ( 5%).

**CHANGES:** If you would like to make changes to your dates, we will do our best to accommodate you. If changes occur during peak season, we will do so if we can re-book your original dates.

**CANCELLATION/REFUND POLICY:** Once we receive this rental agreement, your dates are reserved. If you cancel your reservation at least 61 days prior to your arrival date a processing/cancellation fee of \$100 will be charged. If you cancel less than 61 days prior to your arrival date there will be no refund unless we can re-book your dates. If we can, we will only charge the \$100.00 processing/cancellation fee. If we cannot, you are responsible for the entire stay or what was not re-booked. There are no refunds for poor snow or road conditions, severe weather, mechanical difficulties, maid issues, or early departure. If a problem arises, we will work immediately to remedy the situation.

**CLEANING FEE:** There is an additional \$75.00 set up and clean up fee to prepare the unit for your arrival and to clean after your departure, due at the time of final payment. This fee is for basic cleanup after your departure and for linens. If the departure checklist is not complete you will be charged an additional \$50.00 for the extra cleaning costs.

**NON-SMOKING:** This is a non-smoking unit! If we determine that, during your stay, you have smoked inside the unit, there will be a \$300 fine charged to your credit card.

**PETS:** You are responsible for any costs incurred by your pet. Pet waste must be picked up immediately or you could be fined up to \$100.

**CLUBHOUSE CARD:** There is a \$50.00 fee for a lost clubhouse card.

**KEYS:** This condo does not require keys unless there is a lock failure. In the event that the emergency keys must be used, keys must be returned upon departure. Lost or keys unreturned to lock box will result in a \$300 fine charged to your credit card.

**RETURNED CHECKS:** There is a \$50.00 fee for returned checks.

**OCCUPANCY:** Exceeding maximum occupancy of 8 for this rental unit constitutes defrauding an innkeeper under California Penal Code #537 and such fraud is punishable by a fine of up to \$1,000.00. In addition, you will be required to vacate the premises immediately and you will be charged an additional \$25.00 per extra person per night plus tax. If you wish to have more guests than the maximum occupancy, please contact Sun Snow Lodging, Inc. for approval.

**HOT TUB/POOL:** Tenant and its guests acknowledge that use of hot tubs and pools are at their own risk to injury and damage from the chemicals used to keep hot tubs sanitary which may cause fading in some swimsuits and some individuals may experience mild skin rashes; pregnant women and people with heart conditions or pace-makers are not allowed use of the hot tub and enter it at their own risk and agree to hold Landlord, Owner and Agent harmless.

**DAMAGE/THEFT:** Renter assumes responsibility for any damages to or theft from the unit, including towels and linens. There is a \$50.00 per item replacement fee for lost or stained linens.

**QUIET TIME:** Quiet time is from 10:00PM to 8:00AM. If a noise complaint is reported on your unit, there will be a \$75.00 fee charged to your credit card for the first complaint and \$100.00 fee charged for each additional complaint. If leaving a pet in the condo during the day, you must be sure they are not barking incessantly.

Above fees will be charged for pet complaints.

**CHECK-IN TIME: 4:00PM - CHECK-OUT TIME: 10:00AM:** If there are any persons or possessions in the unit before or after check in/out time without prior approval, all personal items will be removed so that the unit can be cleaned for the next guest and the renter's credit card will be charged for an amount equal to a one night stay at the rental rate stated above. Sun Snow Lodging, Inc. and/or the owner of MeadowRidge 12-15 will not be responsible for any missing or damaged items.
